## September Timeline

5	Submit TASC records for interim mini-tests and predictive interims.
5	Interim mini-tests available for ELA and mathematics.
8	DLM test administrators complete First Contact Surveys and enter PNPs. First Contact Survey must be submitted prior to creating instructional plans.
11	Order materials for PreACT 8/9. Deadline October 20.
11	DLM Instruction and Assessment Planner opens. Teachers must enter instructional plans for ELA and mathematics for each student. Teachers provide instruction on the EE and assess when the student is ready. Blueprint coverage must be completed by December 22.
12	DTC/BTC Virtual Training Webinar @ 1:00 p.m.



#### **KAP Predictive Interim: ELA and Math**



- Interim Guide for Educators and Test Coordinators available on the <u>KAP website</u>.
- TASC records you must submit TASC records through KIDS to "enroll" students in the Kite System for Interim tests.
- TASC submission window begins September 5.
- Predictive Interim tests Kite System auto enrolls students in predictive tests.



#### **KAP Interim: Mini-Tests**



- Mini-tests cover the range of the standards.
- Can be used as formative tools after a unit is taught to check for understanding.
- Reports available; immediate results.
- New mini-tests are added throughout the year as time allows.
- Mini-tests are located under Interim Tab in Educator Portal.



# 2023-2024 KAP Update: ELA Predictive Interim Tests

- Three predictive tests available in grades 3-8, 10
- Items aligned to the 2017 Kansas Standards
- Predict student success on the KAP summative test
- The Kite system automatically enrolls any student with a TASC record in predictive assessment

# 2023-2024 KAP Update: Math Predictive Interim Tests



- ► Three predictive tests available in grades 3-8
- ► Two predictive tests at grade 8 (fall and winter window)
- ► NO predictive interim at grade 10
- ▶ Items aligned to the 2017 Kansas Standards

Winter	12/04/2023 to 12/15/2023	
Spring	1/29/2024 to 2/09/2024



#### **KELPA Screener**



- KELPA Screener opened on 7/31
- Checkbox added during Add Screener Student process to flag student to be retained for next school year (2024 – 2025)
  - Please contact the Kite Service Desk if you have any students who tested late spring or summer that need to be added to 2024 KELPA screener rosters
- KELPA Screener resources can be found under the HELP tab in Educator Portal

### KELPA Screener Kindergarten Alignment Study


- Call for districts to assist researchers in ensuring that cutpoints for kindergarten students are accurate.
  - We need districts to use the KELPA screener in the fall with both EL and non-EL kindergarteners.
  - Looking for students in this study to complete the screener prior to October 13th.
  - One change to "normal" process: Put ENG at the end of the local student identifier of native English Kindergarteners


#### **KELPA Screener Reminders**



- Reminders
  - If a student completes session 3, they need to be scored and the report can be generated after
  - If a student only finishes 1 or 2 and does not get session 3 assigned, they will have a report of 'Not Proficient' automatically assigned

### Kite Technology Updates







#### Deactivate vs. Remove



 Deactivate should be used for any user that is no longer needing a Kite account or is leaving your district.

- Remove should only be used to PERMENANTLY REMOVE A USER from the system (*not just your district*). Only a Kite Service Desk agent or the state can recover removed users.
  - ONLY a DTC may remove a user.



#### Student Portal Current Version



- There is <u>no</u> new version of Student Portal to download for 2023-24.
  - Current testing platforms and their supported versions can be found on the <u>KAP website's Technology Coordinators page</u>.
- In development: A new accessible client and an Android client. Both will be available in the fall.



#### Kite Student Portal for Mac



- Mac OS 11 (Big Sur) will likely lose support in November 2023
- For this reason, we recommend upgrading to macOS 12 (Monterrey) or above.
- Kite Student Portal will be supported on macOS version 12.1 and above



### **Account Locked in Educator Portal**



- Educator Portal gives the user 5 attempts to login before the account gets locked.
  - Users must click on the Forgot Password link at the login page to setup a new password.
  - Once the password has been changed, the account will unlock, and the login attempts will reset back to zero.
- Ensure that the full email address is being entered for the username.
- Please contact the Kite Service Desk if assistance is needed to reset the password

DLM Dates	Date Open	Date Closed
Required Training	August 3, 2023	April 26, 2024
Fall Test Window	September 11, 2023	December 22, 2023
Spring Test Window	February 5, 2024	April 26, 2024



### **DLM Fall Testing Window**



- **September 11 December 22, 2023:** Students must be enrolled and rostered to the appropriate subjects before September 11.
- Teachers must complete the required training prior to having access to students on Educator Portal.
- ELA and Math required for grades 3-8 and 10
- Science only grades 5, 8,11 (optional in the fall)
- Students must meet the blueprint requirements for ELA and math



#### **DLM Enrollment**



- Enroll students who will be taking the DLM in Kite BEFORE you send TASC records for students taking the general assessment
- Students should now be enrolled and rostered to the teacher in the appropriate subjects.
- When students attend a school out of district the attendance school needs to add and roster the student, not the accountability school.
  - Refer to the <u>DLM Manage Special Enrollments Guide</u>.



### First Contact Survey Changes



 All students will need new First Contact Surveys completed in the fall due to changes in the First Contact Survey questions.

### **DLM Monitoring**

#### We encourage you to monitor for:

- Testing outside hours
  - Exit does not save testlet opened outside of school hours evening or weekends
  - Test reset testlet left open of the student's testing device and DLM resets it at 11:05pm
  - Submitted testlet opened and submitted outside school hours (district can request for testlet to be reset)
- Short Duration testing
  - ELA 60 seconds or less
  - Math 30 seconds or less.
  - Science 30 seconds or less
- TIP access (Testlet Information Page access)
  - Teachers should be accessing the TIP prior to administering a testlet to a student. TIPs are individualized for each student and EE based on which form of the testlet is assigned to the student. This document provides all the information the teacher needs on materials for the testlet and if the student needs to be exposed to a familiar text prior to taking the testlet.
- Blueprint completion Teachers are encouraged to use the entire fall test window for completing testlets and meeting the blueprint requirement the blueprint shouldn't be met in just a couple weeks

- Posted on Kansas' DLM website on Aug. 1
- Optional and self-guided
- Interactive lessons from which to choose



## **Dashboard Revisions**



- New DLM data reporting is available
  - Students rostered: shows percentages based on the number of students enrolled
  - First Contact Survey Status: not started, in progress, Ready to Submit, and Completed
  - Testing progress: not started, one or more testlets completed towards meeting Blueprint Requirements, and Blueprint Requirements fulfilled

## Fall WorkKeys



- Registration for Fall WorkKeys paper testing is closed.
- WorkKeys online Validus realm and login information was sent out last week. Enrolling students for online testing can be completed any time prior to the day you choose to test.
- The Validus information is also used to access the WorkKeys online reporting after scoring has been completed. So even if your school is not testing online, the test coordinator should file this information.
- Trainings for online WorkKeys are scheduled for September 14 and September 19. Links to register are in the WorkKeys Schedule of events



### PreACT 8/9



- The PreACT 8/9 for grade 9 students ordering window opened yesterday. Material orders may be placed between now and October 20. The testing window is October 2-November 10.
- There is no student enrollment process for PreACT 8/9.
- PreACT 8/9 administration training is scheduled for September 26.



## Spring 2024 ACT



- Pearson Access Next will open for Spring 2024 ACT on November 7. At that time schools can select test dates and begin enrolling students.
- Testing Accessibility and Accommodations System (TAA) is open now. Requests for approval of accommodations for ACT must be completed by <u>January 5</u>. A reminder that this is a firm deadline.
- Test dates are posted on the Kansas ACT webpage. The ACT Schedule of Events will be posted soon.
