

# Security and Ethics Training

- All District Test Coordinators must complete *in-person* Security and Ethics training held by KSDE and train staff before testing.
- All *in-person district training* must be completed by **January 16, 2026** for anyone administering a **KELPA** assessment
- All *in-person district training* must be completed by **March 13, 2026** for anyone administering a **KAP** assessment in ELA, Math, Science, and/or cPass.

\*\*\*These dates may vary depending on the needs of your district. Please note that **all staff** administering summative assessments must complete Security and Ethics training **before** the testing windows open.



# Security and Ethics Training

- Documentation of training should be kept at the building and district level.



# Special Circumstance Codes

- SC-11 KELPA and WIDA Alt ACCESS only
  - Fill out the form for approval from KSDE.
  - Access form from Educator Portal.
  - Go to the KELPA Assessment.
    - Help > Special Circumstance Code > KELPA and WIDA Special Circumstance Request Form
- SC-08 and SC-39
  - Fill out application for approval from KSDE and email to Chelsea Pelfrey.
  - Access application from any assessment program in Educator Portal.
    - Help > Special Circumstance



# Special Circumstance Codes

- All Special Circumstance Codes must be entered before the end of the testing window for the assessment it is requested for.
  - You will not enter a code anywhere for WIDA. That will be taken care of after the window closes by KSDE.



# Unique Accommodations

  - We do have a Unique Accommodations form that we will provide to the DTC after the initial conversation.



# TTS Passages and Graphics

- Text-to-Speech Passages and Graphics Applications
  - Protocol for accommodations in reading
  - Due by the end of the day on January 31. No exceptions.
  - DTC **must** be the person to submit them to [TTSpassages@ksde.gov](mailto:TTSpassages@ksde.gov) .
  - Remember to submit **all** applications at one time.
  - All applications must be signed.
  - Resubmissions are **not allowed**. Please review thoroughly before submitting.
- Double check your SIS system to ensure students are marked correctly for WD (with disability) or a 504 plan for all students with submitted applications.




# TTS Click Data for ELA

- Questions and Responses – 3701 students never accessed the TTS
- Passages and Graphics – 108 students never accessed the TTS

## Next steps

1. Email will be sent next week to districts who had students who didn't access the TTS (broken down by Q&R and P&G).
2. DTC can follow up with Cary or Chelsea to get the SSIDs.
3. If student doesn't use TTS in the classroom don't select on PNP.
4. If student needs the accommodation make sure they know how it works. Utilize the practice tests and interim or mini-tests with TTS set.

# KELPA Testing and Scoring Windows

- Testing Window
  - February 2 – March 13, 2026
- Scoring Window
  - February 2 – April 6, 2026
  - Scoring can be done simultaneous (while student is recording) or deferred (after student has finished recording).

# Scoring Recommendations

- Scoring may begin as soon as the testing window opens. It is not advised to wait until the end to complete all scoring.
- It is **suggested** that the speaking and writing sections be administered earlier in the testing window, then the listening and reading sections. This allows for more time to complete the scoring of items.
- Don't forget to spot check recordings to ensure that responses have been saved **prior** to the end of the testing window.



# Second-Rater Scoring

- Simultaneous scoring is not available
- If your school has more than 10 students testing in a grade level/grade band, you may be randomly selected to participate in second-rater scoring.
- Students flagged for second-rater scoring are automatically flagged in Kite and the second-rater scoring option under scoring populates only students with the second-rater flag.



# Reminders

- Students on monitored and transitional status **do not** take the KELPA.
- A **para**, under the direction of a licensed educator, may **proctor** the KELPA assessment if they have gone through the required Test Security and Ethics training.
- K-1st grade students use writing booklets printed by Test Coordinators, that are found in the HELP Tab.
  - Booklets must be scanned and uploaded to EP before the end of the scoring window.
  - Upload a separate file for each grade.
  - Destroy booklets once upload is complete.



# Reminders

- Speaking domain does not have to be in a one-on-one setting.
  - Best practice to have ample spacing between students when they are recording their responses.
- Utilize [Kite Practice Tests](#) to familiarize students with the testing platform and using the microphone to record responses.









  - Pop up notification: Requirement of approval application
- PNP Summary tab – Users with view only
  - Detailed information on PNP set for students

    - Final results for your district prior to Feb 6<sup>th</sup>
    - Reports generated for students left in progress
  - How?
    - DTC must contact the Kite Service Desk and let them know the desired end date for the district





# Instructional Mini Test Feedback

- Share your thoughts on Instructional Mini Tests
  - Interim > Build a Test
    - Your Feedback – lets you leave comments and review feedback you've already shared on that test.
    - All Feedback – shows feedback from educators across Kansas.
      - "All Feedback" will only provide data after at least 5 educators have entered feedback
  - All roles can leave feedback
  - Leave feedback on all three subjects!

- Reminders!
  - Must be from the same subject
    - Cannot combine ELA, Math and Science items
  - Must be from the same grade
    - Cannot combine different grade levels
  - Group Math items by Calculator Status



# NAEP Practice Tests – Coming soon!

- NAEP tests are scheduled for administrations in select districts/schools in January – March 2026.
- To allow for easier access to NAEP Practice Tests, Kite will provide sample practice items that can be taken in Student Portal
- Targeted Release: End of January
- Test will be available as Instructional Mini Tests and will be found within Build or Copy a Test
  - Form names: NAEP ELA Practice Test & NAEP Math Practice Test



# ELA Spring Interim Instructional Mini Pre-Tests

- Two passage-based blocks of items
  - One literary passage and one informational passage
- Eight items per passage – mixed reading and writing
- Truncated Interim 2 blueprint
- Designed to be taken before or after the Spring Interim assessment to support student instruction.

# Special Circumstance Codes

- Two options to apply SC codes for KELPA manually
  1. Test Session (Existing option)
  2. Student
- SC-11 is now restricted in EP to be applied to **one** domain
  1. If entered on 2 or more domains
    - Manually - Receive a pop-up error message
    - Upload – Row on upload will be rejected

- Review Testlet Information Page (TIP) access for the fall test window
  - Make sure teachers understand the importance of accessing the TIP
  - Make sure they know how to access the TIP




# WIDA Alternate ACCESS

- WIDA Alternate ACCESS is given to identified English learners (ELs) with the most significant cognitive disabilities during the annual testing window.
- District Test Coordinators (DTC), Building Test Coordinators (BTC), and Test Administrators (TA) can utilize the [WIDA Alternate ACCESS Checklist](#) to stay informed on tasks that need to be completed before, during, and after the test window.

# PreACT 8/9 and Fall WorkKeys Scoring

## PreACT 8/9

- Score reports have been mailed to schools.
- Score reports are posted in online reporting in Success.

## WorkKeys

- Score reports and NCRC certificates are posted in online reporting in Validus.
- Mailed reports will be mailed beginning January 16.



# Spring 2026 ACT

## Accommodations

- Requests for the test window beginning February 24 must be submitted for approval by January 14. For the April 7 window, the deadline is February 25.

## Student enrollment

- SDUs must be submitted by January 16 to enroll students for paper or online testing.
- The SDU submission creates the materials order. Be sure to check that TAA PINs are attached to students with approved accommodations so their accommodations materials will be ordered.



# Spring 2026 WorkKeys

## Accommodations


- Accommodations do not require approval from ACT for WorkKeys. After the students are enrolled, schools manually select accommodations materials for students as determined by local accommodations provided.

## Paper testing

- SDUs must be submitted by January 16 to enroll students for paper testing. The SDU submission creates the materials order.

## Online testing

- Validus login and realm information will be sent to building test coordinators on January 28. Test coordinators may then enroll students through Validus and set up online test sessions.
